The company's business purpose covers the following, excluding any activities which are prohibited or subject to specific requirements: the trade of timber and semi-finished wooden items, any kind of wooden packaging and wood processing machinery, both in Italy and abroad; - the trade of plastics, plastic semi-finished and finished products and PVC materials, both in Italy and abroad; - the trade of silver and mineral ore in general, metal scrap, copper, aluminium and brass bars, ingots and plates, both in Italy and abroad; - the trade of steel items, such as beams, rebar, wire rod, blooms, coils and welded mesh, both in Italy and abroad; - the trade of precious stones (such as diamonds, rubies and sapphires), coloured stones (such as topaz, aquamarine and tourmaline) for industrial and other applications, both in Italy and abroad; - the trade of cement, crude oil, diesel gas in general, chemicals and petroleum derivatives, both in Italy and abroad; - the trade of sugar, mineral and vegetable oils, both in Italy and abroad; - the carriage of goods for hire or reward both in Italy and abroad, business agency for the management and distribution of carriage for hire or reward, motor vehicle rental with or without driver, haul moving and storage service in all its forms, the management of bodywork and tire repair shops for own and other vehicles, the storage and distribution of fuel, vehicle washing stations, the management of vehicle parking areas, the loading and unloading of goods and distribution for all transport-associated activities, including technical, administrative and accounting assistance as required, the loading and unloading, storage and warehousing of goods, and the management of stores and warehouses.
